T. Bates attended the public exhibition on Proposed Challens site extension. The impact on Willington is negligible apart from the fact that the existing processing plant and vehicle access from Castleway would remain in operation for the duration of the next phase of extraction from the South side of the river Dove. The initial extraction is quite close and visible to the village across the Trent and will probably need bunding higher than CEMEX are proposing during the early phase of extraction to win over the villagers. They will

also have to put a temporary bridge over the Dove to get the gravel to the processing plant and divert a footpath on the South bank of the Dove.

Regarding our proposed path, CEMEX advised that the majority of fencing within the CEMEX site is now completed and all that remains to be done from their point of view is some grass and hedge cutting. They, like the Council, now await the Wildlife Trust.
