It was discussed that consideration should be given to a coded padlock as opposed to a key system (code would be changed regularly) and it was **AGREED** to recommend this to Council to save the cost of key cutting etc.

**Bowls Club** – it was **AGREED** that a meeting would be held with the Bowls Club ahead of the next RAC meeting to discuss the mower servicing/maintenance and annual rent. Cllrs. M. Bartram, T. Bartram, C. Mead and J. Houghton would be available to meet with them.
