5. ELIGIBILITY

Interments for non-parishioners are not allowed.

The foregoing fees are to be applied where the deceased has lived in the Parish of Willington for 12 months prior to his/her interment. This is to be verified by inclusion on the electoral role.

In consideration of special circumstances e.g. where a Parishioner of Willington has not lived in the village for 12 months prior to his/her interment, internment may be permissible at the Clerk's discretion, subject to double the foregoing fees, payments and sums.

Reservation of plots for burials or interment of ashes is not permitted.

At a meeting of the Parish Council of Willington held on the 12th day of March 2019, the foregoing fees, payments and sums, payable under Section 34 of the Burial Act 1852, are hereby fixed and settled by the said Parish Council, to commence from 13th March 2019.
